The PIR Swap meet reserves the right to exclude without any recourse any person or items, which violate the following rules, or are otherwise deemed objectionable.

1. **Only automotive related items are acceptable at the PIR Swap Meet.** The following items are not acceptable: food & beverage sales; flammable gasses, liquids or solids; knives; guns or pornography.
2. Applications for stalls are processed on first come-first assigned basis. Returning vendors have until January 1 to renew the same space as the prior year. All vendor stalls are outdoors and have 20' of frontage.
3. Vendors who are placed on asphalt must provide a tarp to cover their space to prevent oil spillage.
4. No vendor parking permit is required for vehicles entering the swap meet and remaining in the vendor stall – however, all occupants of that vehicle must have vendor passes. You may park as many vehicles within your vendor stall as you wish. Your Vendor Parking Permit is to be used for any vehicle that needs “in and out” privileges during the event hours.
5. Vendors will be admitted one hour earlier than the posted opening hours each day during the event. Vendors must be moved in by opening hours each day. There will be no vehicle traffic on the track after 10:00 am without a pilot vehicle. There will be no vendor move-in after 9:00 PM.
6. Vendors will receive two vendor passes with each vendor stall rented. Additional passes may be purchased for \$10.
7. Cancellation of vendor space will be accepted by March 1 for a 100% refund; cancellations received between March 1 and March 30 will result in a 50% refund. After that date no refund will be provided. If you are not able to occupy your space, please let us know so that we may fill your space.
8. Alcohol is not allowed to be brought on the Portland International Raceway grounds at any time.
9. Overnight camping is permitted in your vendor stall, or in the campground outside the Swap Meet grounds.
10. Overnight security is provided; however we recommend you secure your belongings. PIR is not responsible for any loss or damage.
11. There will be no parts-pick up on the track during the hours the event is open to the public. Those needing to pick-up parts or vehicles will be directed to the parts-pickup area through the main gate. If the customer needs to go on the track to pick-up something, they will (for a fee) be escorted in.
